<u>Circular seeking options for absorption into Andhra Pradesh Vaidya Vidhana Parishad, service from employees eligible for giving Options:</u>

- a) Specialist Doctors working in APVVP in terms and conditions of deputation of Foreign Service.
- b) All the employees working in 122 newly transferred institutions (vide G.O.Ms.No.124, Dated 13.10.2015 HM&FW (B1) Dept.) (Copy enclosed) from the Directorate of Public Health & Family Welfare as on the said specified date i.e. 1st April, 2018
- c) All the employees working in 5 Community Health Centers (Copy enclosed) transferred from DPH & FW (vide G.O.RT.No. 265 HM & FW(D1) Dept., dated:28.06.2018) as on 01.11.2018.

Andhra Pradesh Vaidya Vidhana Parishad is a body corporate formed by Act 29 of 1986 of A.P.Legislative Assembly in November 1986.

The Service Rules for APVVP were issued vide G.O.Ms.No.48, HM&FW(C1) Department dated.29.01.2000 and published in A.P.Gazzette in February 2000 naming them as APVVP Special Service Regulations 2000 and amendments issued if any.

Conditions of Service to the Employees (Regulation No.9):

- (1) In addition to these regulations and wherever necessary all codal rules and service rules applicable to all categories of Government employees in Government service are also applicable to the similar or corresponding categories of employees of the Commissionerate, so long as they are not inconsistent with these regulations and regulations on General Service Matters of the Commissionerate.
- (2) The pay and allowances, leave, pensions, gratuity, provident fund and age of superannuation in respect of the Government employees on deputation to the Commissionerate and who shall be absorbed into Commissionerate service shall not be less favourable than those applicable to such employees immediately before such absorption. The service rendered by such Government employees on deputation after their absorption in the Commissionerate shall be deemed to be service under the Commissionerate and they shall be entitled to count that service under Government for the purpose of seniority, increments, leave. Pension, provident fund and gratuity.
- (3) The service conditions, pay and allowance, leave, pension, Gratuity, Provident fund, age of superannuation and other retirement benefits of the employees of the Commissionerate those recruited after 01.11.1986 shall be on par with Government employees.
- N.B.: Government issued reiterating orders vide G.O.Ms.No.184, Dt.18.05.2006 towards pension and other terminal benefits for all APVVP employees and employees absorbed in APVVP. In G.O.Ms.No.57 issued clear instructions regarding pensionery benefits to the APVVP recruits and absorbed employees.

Constitution of the posts Unit System (Regulation – 6) APVVP is brought into the purview of presidential order vide G.O.Ms.No.G.O.Ms.No.348, HM & FW(C1) Dept., dated:30.10.2007:

The posts in the Commissionerate service are divided into State Level Posts, Head Office Posts, Zonal Level Posts and District Level Posts.

Seniority (Regulation 6 (c)(V):

Separate seniority lists shall be maintained for the employees under each category of posts falling under State Level , Zonal Level, District Level posts and Head Office Posts.

<u>Deputationist who are not willing for absorption { Regulation 4 (c)} :</u>

The employees who are on deputation and do not opt for absorption in the Commissionerate service may continue on deputation and they shall not be eligible for promotion in the Commissionerate and shall be liable to be recalled by the parent Department or repatriated to the parent Department as per rules in force.

Last date for exercising Option:

The Option Form shall be submitted on or before 5.00 PM of 31.10.2019.

<u>Important Note:</u>

Mere Exercising option doesn't confer any right on the employee for absorption of his/her service into APVVP service. Absorption will be depending on the need of the particular service in APVVP, vacancy position available in APVVP and No objection from parent Department. The candidature of the employee will be considered basing on the seniority of the employee. The employees who are under punishment and facing charges are not eligible for absorption. Commissioner's decision is final in this matter.

ORDER:-

In the G.O., 1st read above, orders were issued for establishment of Community Health & Nutrition Clusters as per the list of CHNCs , FRUs , PHCs as detailed in G.O., with a view to have a Referral Hospital for every CHNC in the state. As per the Govt. orders, there are 120 First Referral Units / CHCs functioning under the administrative control of Directorate of Public Health & Family Welfare and on submerging of 7 mandals from Khammam District, 2 FRUs have been added in East Godavari District and hence there is a total No. of 122 FRUs functioning.

- In the Review Meeting Dt.26.9.2015 held by the Hon'ble M(H&ME), with the Prl. Secy., to Govt., HM&FW Deptt., DPH&FW and Commissioner, A.P.V.V.P., it has been unanimously agreed that all the CHCs., under the Control of the DPH&FW, A.P., be transferred to the control of the Commissioner, A.P.V.V.P., so that all secondary care (curative services) under one establishment and proposals to cover all institutions under new sanitation policy.
- In the letter 2^{nd} read above, the DPH&FW, A.P., Hyd., has informed that as per the decision taken during the Review meeting held on 26.09.2015, if the Govt. desires to transfer the FRUs which are functioning under the control of the Directorate of Public Health & FW to the control of Commissioner, A.P.Vaidya Vidhana Parishad, the infrastructure / Budget / posts sanctioned / Movable & immovable assets may also be transferred to the control of Commissioner, A.P.
