The District Medical and Health Officers are requested to process the transfer applications with the help of the R.D.M.H.S. concerned and in consultation with District Collectors concerned . They are further requested to circulate the files on transfers to the District Collectors and get orders from time to time where ever necessary.

The following procedure may be prescribed while undertaking this exercise:

1. The R.D.M.&H.S and D.M.&H.O.s are requested to undertake the transfer exercise in a transparent manner as per the guidelines issued in G.O.Ms.No. 57 Finance ( H.R.I. PLG.& POLICY) Department Dated: 08.05.2018.
2. The competent authority shall examine/scrutinize the applications and shall process them on or before 24th May 2018.
3. The preferences of eligible employees and in-eligible employees lists shall be exhibited at a prominent place in the premises of the office as well as in Departmental web site.

4. The transfer orders finalized by the competent authority should be kept in web.site by 30<sup>th</sup> May 2018, so as to enable the employees to download transfer orders from web.site.
5. All the Transferred employees shall join in the new places on or before the A.N. of 4<sup>th</sup> June 2018 without fail.
6. The R.D.M.& H.S. / D.M.&H.O.s concerned are responsible for the implementation of the transfer orders in the most transparent manner possible without giving any scope for complaints / allegations. Any violation of the government orders issued through the references cited will be viewed seriously.

After completion of the transfer process all the R.D.M.&H.S. and D.M.&H.O.s should send the compliance report to the this office by 05.06.2018 without fail.
