- 7). The vehicle shall be provided on any day including Saturday, Sunday and holidays if required by the department.
- 8). The vehicle should be in good running condition. In case break down of the vehicle the agency /firm has to arrange alternate vehicle on his own cost. In case no replacement is provided on time the DPHFW has a right to hire a vehicle from the market and the cost incurred has to be borne by the agency / firm.
- 9). The agency shall not engage any sub agency or transfer the contract to any other person.
- 10). The vehicle must be fitted with fire extinguisher in proper working condition at all time and the driver should be trained to use them.

- 11). There should be at least two sets of white covers, towels and napkins. It should be changed every week. There should be an air spray in car. The items mentioned shall be made available at the cost of the owner of the firm.
- 12). The vehicle should be registered in the name of the agency / firm / vehicle owner with the concerned authority of central / state government. Self attested photocopies of Registration certificate, Insurance, Fitness and tax paid receipt should be attached with the tender. The vehicle should be comprehensively insured with the pollution certificate.
- 13). The vehicle should have necessary permits from the concerned authority. This office will not be responsible for any challan, loss, damage and accident to the vehicle or any other vehicle or injury to anybody.
- 14). In case of any accident, all the claims arising out of it shall be met by the agency / firm / vehicle owner.
- 15). If any of the terms and conditions above, is not found fulfilled during the currency of contract, the director of public health and family welfare, Vijayawada reserves the right to terminate the contract without assigning any reasons thereof. However, this contract can be terminated with a notice period of one month by the either side.
