Dr.D.V.Vijayalakshmi, MO, formerly at PHC, Irala, Chittoor Dist. was placed under vide reference 1st cited by DM&HO,Chittoor for proceeding on unauthorized absence from duty on 6-5-2008 during the epidemic out break and requested for ratification. Ratification orders were issued vide 3rd cited and charges were framed against her vide reference 4th cited. She has submitted explanation which is not convincing and the Addl. DM&HO, Chittoor has been appointed as Inquiry Officer vide reference 6th cited and the Inquiry Officer has submitted the Inquiry Report vide reference 7th cited, Inquiry report has been communicated to her and she has submitted her representation. After careful examination punishment of stoppage of 2 Annual Grade Increments without Cumulative Effect was imposed on her.

Re-instatement Orders were issued vide reference 11th cited posting at PHC, Mudipapanapalli, Chittoor Dist. The DM&HO,Chittoor informed Lr.dt. 03-03-2011, (reference 16th cited) that there is no vacancy at PHC,Mudipapanapalli and instructed her report before the Director of Health for further postings and the same was returned to his Office undelivered.

The DM&HO, Chittoor further informed vide reference 16th cited, that she send a telegram to his Office for sanction of subsistence allowance from 10/2010. She shall not leave bonafide H.Q during the suspension period without permission and in case if the employees under suspension wants to leave HQs one shall obtain prior permission by informing temporary address, but she left the H.Q without giving temporary address and without informing temporary address. He added that she has left from her bonafide HQ without giving her temporary address and without obtaining prior permission. She used to sent all her representations, other correspondence in covers as Dr.D.V.Vijayalakshmi, (U/S),PHC,Irala. but actually the letters are from Tirupathi and the copy of the letter directing her to report before DH has also marked to the MO, PHC,Irala chittoor Dist and the same was returned to the office of the DM&HO,Chittoor, by the MO irala, stating that the above individual is not staying in her bonafide HQ. and the preset address is also not available in the PHC.

She has not reported for duty even after issue of reinstatement orders dt. 02-02-2010.

Therefore she is directed to submit her explanation within (15) days, from the date of publication of this notice as to why the penalty of termination from service shall not be imposed on her, with effect from 02-02-2010 (date of issued of re-instatement orders) in terms of in terms of G.O.Ms.128,Fin.(DR.1) Dept. Dated.01-06-2007 & G.O.Ms.129, Fin.(DR.1) Dept. Dated.01-06-2007.

If no reply is received from him within the above said stipulated period, it is presumed that he has no explanation to offer and action will be taken as proposed above based on the material available.

The notification will be published in an extraordinary issue of the A.P. Gazette.
