In the reference first read above, Government have issued orders approving a list of new Essential Medicines List and Additional Medicines List for 2013.

2. In the reference 2<sup>nd</sup> read above, the M.D., APMSIDC has reported that, in the list of new EML the Tab Erythromycin 250 mg was available instead of Tab Erythromycin 500 mg. As per the requirement from the end users, the Tab Erythromycin 500 mg is more necessary dosage for adult patients. He has therefore requested to change the strength of Tab Erythromycin from 250mg to 500 mg.

3. Government after careful examination, hereby issue the following amendment to G.O.Ms.No.204, HM & FW (M2) Dept., dated.17.12.2013 against SI.No.193, Erythromycin Tablets.

AMENDMENT

In the Annexure at page 11 serial No.193 Code No.239, Erythromycin Tablets under specification Erythromycin stearate Tablets shall be read as “500mg” instead of “IP 250Mg”

The Managing Director, APMSIDC, Hyderabad shall take further necessary action accordingly.
