It is brought to the notice of the under signed certain Civil Assistant Surgeons who have completed their P.G. Diploma / P.G. Degree Courses have been issued reposting orders as Specialist Civil Assistant Surgeons under the administrative control of the Commissioner, A.P. Vaidya Vidhana Parishad, Vijayawada in terms of G.O. reference 3<sup>rd</sup> to 5<sup>th</sup> cited, since they must serve the Government of Andhra Pradesh for a period of (5) years on completion of P.G. Courses. Otherwise they should pay Rs.20,00,000/- (Rupees twenty lakhs only) and pay and allowances received for the P.G. Course period.

But some of the said Civil Assistant Surgeons have not reported at their place of posting and proceeded on unauthorised absence as per the information furnished by the Commissioner, A.P. Vaidya Vidhana Parishad, Gollapudi, Vijayawada.

Accordingly disciplinary action has been initiated against those Civil Assistant Surgeons duly issuing Charge Memo to them as per CCA Rules. Most of them not responded for the Charge Memo and no explanation is received from them.

In view of the above, the Specialist Civil Assistant Surgeons mentioned in the Annexure enclosed are hereby issued notice to report before the Director of Public Health & Family Welfare, A.P., Vijayawada immediately within (10) days from the date of issue of this notice. Otherwise necessary steps will be initiated against them to recover Rs.20,00,000/- (Rupees twenty lakhs only) and total salary received for the P.G. Course period as per Revenue Recovery Act and rules and regularization laid down in G.Os reference 3<sup>rd</sup> to 5<sup>th</sup> cited.

This web site notice shall be treated as official communication to the individual without any acknowledgement and further course of action will be initiated against them.
