
It has been brought to the notice of the Director of Public Health & Family Welfare ,A.P., Hyderabad vide reference cited, that Dr.BNVJ.Sravanthi, CAS., was appointed by the Director of Public Health & Family Welfare and posted at Civil Assistant Surgeon, PHC, Ganapavaram, West Godavari District . She has proceeded on unauthorized absence from 01.01.2015 which has resulted deprival of patient care of the needy people in the Primary Health Centre and with their above mentioned act of misconduct has exhibited lack of integrity and devotion to their duties and violated Rule (3) of A.P. C.S.,(Conduct )Rules -1964.

Hence, under provisions of F.R.18(A) as amended in G.O.1<sup>st</sup> cited and as per Rule 5-B of A.P. Leave Rules-1933, and terms and conditions mentioned in the appointment order it is provisionally decided to confirm that the above mentioned individual shall be deemed to have been resigned from service as Civil Assistant Surgeons w.e.f. the date of their unauthorized absence .

Hence, Dr.BNVJ.Sravanthi, CAS., PHC, Ganapavaram , West Godavari District is here by directed to show cause within (15) days from the date of receipt of this notice as to why it should not be confirmed that she shall be deemed to have been resigned from service as Civil Assistant Surgeon. If not received any representation it will be construed that she has no representation to give and it will be treated as resign.
