Dr.S.Iliyas Basha, formerly, MO, PHC, Pakala, Chittoor District was selected to the post of Civil Assistant Surgeon during the recruitment of CAS-2006-2007 and joined in duty on 04-02-2008 F.N. and he went on Un- authorised absence from duty w.e.f 25-8-2008 onwards without prior permission from the competent authority. He has submitted a representation in the reference cited stating that he worked as CAS in PHC, Pakala, Chittoor District from 4-2-2008 to 24-8-2008 and discontinued the service to continue his higher studies without service quota from 28-8-2008 to 27-8-2011 (PG in MS in G.S in Narayana Medical College , Nellore ) and after his PG, because of his personal family and financial problems he traveled abroad and worked in ministry of health, Kingdom of Saudi Arabia and requested for posting.

Therefore he is directed to submit his explanation within (15) days, from the date of publication of this notice as to why the penalty of removal from service shall not be imposed on him with effect from the date of his un-authorised absence in terms of in terms of G.O.Ms.No.128, Finance (FR.1) Dept., dt.01-06-2007.

If no reply is received from him within the above said stipulated period, it is presumed that he has no explanation to offer and action will be taken as proposed above based on the material available.
