ORDER:

It has been brought to the notice of the undersigned that Dr.C.Manohar Gandhi, CAS, CHC, Pamidi, Ananthapuramu District has been selected to the post of Civil Assistant Surgeon and joined in service on 19-02-2008 and he went on Un- authorised absence from duty w.e.f. 01-12-2014 onwards without prior permission from the competent authority.

Therefore he is directed to submit his explanation within (15) days, from the date of publication of this notice as to why the penalty of removal from service shall not be imposed on him with effect from the date of his un-authorised absence in terms of in terms of G.O.Ms.No.260, General Administration (Ser. C)Dept., dt.04-09-2003.

If no reply is received from him within the above said stipulated period, it is presumed that he has no explanation to offer and action will be taken as proposed above based on the material available.

In another case, he has been served with Show Cause Notice vide Rc.No.6627/VC.IIIA/2014, DT.25-06-2015 for his Unauthorised absence from 10.04.2008 to 23.01.2013 while he was working at MMU, Kalyandurg, Ananthapuramu District, for imposing major punishment. Even after receipt of the Show Cause Notice he has not yet submitted his explanation, and it shows his negligence on the part of administration and dereliction of duties.
