Course without permission from the competent authority. She has been served a Charge Memo. vide reference 2nd cited and she has submitted her explanation vide reference 3rd cited stating that she has joined in D.N.B. Anaesthesiology (Post MBBS) at K.G. Hospital & PG Medical Institute, Coimbatore Tamilnadu without permission.

2 Show Cause Notice has been issued to her vide reference 4th cited as well as publishing the Show Cause Notice in the News paper to submit her explanation within (15) days from the date of publication of the Show cause notice as to why the penalty of removal from service shall not be imposed on her with effect from the date of her un-authorized absence in terms of G.O.Ms.No.260, General Administration (Ser.
