## All DM&HOs shall follow the following:

- 1. All the DM&HOs should utilize the released funds only after taking the prior approval of the Districts Collectors.
- 2. Only Signed Expenditure Statements by DM&HOs will be accepted.
- 3. Funs shall be utilized strictly according to the District ROPs and according to the Guidelines issued by the Govt. of India / Govt. of A.P / State Schemes implementing officers scrupulously.
- 4. Reappropriation from one FMR code to another will not be entertained.
- 5. All the DM&HOs should furnish the consolidated U.Cs HDS / United funds / AMG to SPMU (Finance) by 6<sup>th</sup> of every month.
- 6. All the DM&HOs should send monthly audited statements to SPMU (Finance) by 10<sup>th</sup> every month.
- 7. All the DM&HOs should inform Irregularities / Mis-appropriation if any to the State Programme Implementing officer under intimation to SPMU (Finance).
