- 3. Regular Cleaning and Painting of GLSR/ OHSR.
- 4. Spray Operation for Control of Vector Borne Diseases.
- 5. Organization of Nutrition Health Days AWCs.
- 6. Organization of Monthly VHNSCs meeting for reviewing Indicators under Social Empowerment Mission.
- 7. Providing Health Risk Funds to Village Organizations.
- 8. All other expenditure with the approval of VHSNC Members.

The DM&HOs and DPMOs (NHM) are instructed to furnish the Activity Wise Monthly Expenditure Statements and Utilization Certificates separately to the Commissioner of Health and Family Welfare by 31.03.2015, so as to submit the expenditure report to Government of India.
