- **B. Age :** Upper age limit is 42 years. Age will be reckoned as on 01-07-2024 with the following relaxations as applicable.
  - i. For SC, ST,BC and EWS: 05 (Five years).
  - ii. For ex-service Men: 03 (Three) years in addition to the length of service in armed forces.
  - iii. For Physically Challenged persons: 10 (Ten) years.
  - iv. Specialist doctors will be allowed to contract / quotation basis appointments up to the completion of the age of 70 years by 01.07.2024.

#### C. Reservation:

Reservation will be as per A.P. State & Subordinate Service Rules in force. Contract appointment will be in relaxation of the Rule of Reservation in terms of reference 14<sup>th</sup>cited.

#### D. Local Candidature:

a) A.P.
