

I further submit that the Director of Secondary Health, A.P. has accorded permission to fill-up 84 vacancies in Zone-II. Out of which, 4 roster points earmarked for Sports Category. Hence, this office has addressed the Sports Authority of A.P. for genuinity of 4 (four) Sports Certificates. Reply is awaited. Hence, the selection was made for 80 vacancies as per merit-cum-rule of reservation and submitting herewith the selection lists in category-wise selection and as per merit-cum-rule of reservation by keeping the roster points pertaining Sports Category for your kind perusal and the same was placed in the CFW website.

I further submit that the Govt. have issued orders in G.O.Ms.No.68, SW(V) Dept., dated 16.04.1988 stating that the Staff Nurse posts located in ITDA area shall be filled with Local ST candidates only. Hence, I request kindly to observe the same while issuing posting orders.

Hence, I request kindly to verify the original certificates of academic/ technical and service certificates prior to issue of appointment orders. On verification of certificates, they may be appointed as Staff Nurse on contract basis subject to the condition that if their certificates found fake in future, they are liable for departmental / criminal proceedings as per rules in force.
