Terms and Conditions :-

- I. The Private vehicles, which are registered as a Taxi can only be hired for Government duty.
- II. The owner of the vehicle hired for Government duty should produce the pollution control certificate for every Six(6) months.
- III. The owner of the vehicle hired for Government duty should produce valid documents like Permit, Fitness Certificate, Insurance, Tax etc., while applying to Government for providing the vehicle for hire purposes.
- IV. The owner of the vehicle hired for Government duty should also produce the Professional Driving License with badge of the driver proposed to be engaged.
- V. The fuel charges and crew charges and all types of repairs to vehicles are to be borne by the vehicle owners.
- VI. The approximate length covered in a month is about 2500 KMS only (Rs.10/- per KM over and above 2500 KMs).
- VII. The quoted rate more than rates stipulated in the G.O.Ms.No.87, dated 01-06-2017 of the Finance Department, (HR.VI- TFR-VA) will be rejected.
- VIII. The vehicle along with driver shall be kept ready at any time as and when required by the concerned Officer.
- IX. The vehicle offered shall be less than 3 years of age since their manufacture.
- X. A log book for the vehicle should be maintained.
- XI. In case of breakdown of the vehicle for any reason, an alternate vehicle should be provided by the vehicle owner.
