It is to submit that as per the references 1st to 9th cited above; the selection list was prepared and communicated to the selected candidates for filling up of the vacant posts of staff nurses on contract basis scrutinized by the RDM&HS,Zone-1 and communicated to the Commissioner, Director of Secondary Health (APVVP), Vijayawada for conduct a counselling and issue appointment orders.

It is hereby informed that as part of the ongoing recruitment process for the post of Staff Nurses under APVVP, it is imperative to ensure complete transparency and adherence to the rules of reservation as per the Government guidelines.

You are requested to verify all the roster points applied during the selection process to ensure that the reservation norms and roster system have been correctly implemented.

Further state that the Final Merit List was published on the CFW website dated 28/06/2025. Based on merit and roster points, the Selection List was prepared and displayed on the CFW website on 02/07/2025. The concerned authorities under Secondary Health are responsible for verification of original certificates during counselling and prior to issuance of Appointment Orders to the selected candidates.

It has come to notice that certain candidates submitted fabricated certificates, including marks memos and COVID service weightage certificates. These were identified during the application verification process, and the cases have been referred to the respective authorities such as the DME Nursing Wing and the Superintendent of KGH for genuineness verification. The candidates who were found to have submitted fake certificates were mentioned in the Final Merit List but they were denied for selection, and police report have been issue in this regard.

Further, verification of genuineness on certain certificates is still pending from Dr. NTR University, AP, Vijayawada. Therefore, it is hereby requested to mention in the appointment order as " if any certificate submitted by the candidate is found to be fake or fabricated at any stage, necessary legal action will be initiated against the individual concerned.

In addition to this, **verification of original certificates** of all selected candidates must be undertaken meticulously. This includes verification of educational qualifications, caste certificates, experience certificates, and any other documents submitted in support of their candidature.
